HONOURABLE SRI JUSTICE SURESH KUMAR KAIT**CRIMINAL PETITION NO. 17212 OF 2016****ORDER :**

This Criminal Petition is filed by the petitioners/A-1 and A-2 under section 482 of Cr.P.C. seeking to relax the conditions imposed on the petitioners/A-1 and A-2 in CrI.MP.No. 3432 of 2016, vide order dated 25/10//2016 passed by the Metropolitan Sessions Judge-cum-I-Additional District and Sessions Judge, Visakhapatnam.

2. Keeping in view the averments made in the said petition and submission of the counsel for the petitioner/accused, I hereby modify the order dated 25/10/2016 passed by the Metropolitan Sessions Judge-cum-I-Additional District and Sessions Judge, Visakhapatnam, in CrI.MP.No. 3432 of 2016 by relaxing the condition and release the petitioner/accused on bail on executing a personal bond of Rs.50,000/- [Rs. Fifty Thousand only] each with

two sureties for the like sum to the satisfaction of Additional Chief Metropolitan Magistrate, Visakhapatnam, Visakhapatnam district.

3. I hereby make it clear that all other conditions imposed by the I-Additional Sessions Judge, Visakhapatnam, shall remain in force for a period of three months or till filing of the charge sheet, whichever is earlier.

4. Accordingly, the order dated 25/10/2016 passed by the Metropolitan Sessions Judge-cum-I-Additional Sessions Judge, Visakhapatnam in CrI.MP.No. 3432 of 2016 is modified to the extent indicated above.

5. Accordingly, the Criminal Petition is allowed.

6. As a sequel, miscellaneous petitions if any, pending in this Criminal Petition shall stand closed.
