HONOURABLE SRI JUSTICE SURESH KUMAR KAIT**CRIMINAL PETITION NO. 17214 OF 2016****ORDER :**

This Criminal Petition is filed by the petitioners/A-3 to A-5 under section 482 of Cr.P.C. seeking to relax the conditions imposed on the petitioners/A-3 to A-5 in CrI.MP.No. 3873 of 2016, vide order dated 17/11/2016 passed by the Metropolitan Sessions Judge-cum-I-Additional District and Sessions Judge, Visakhapatnam.

2. Keeping in view the averments made in the said petition and submission of the counsel for the petitioners/A3 to A5, I hereby modify the order dated 17/11/2016 passed by the Metropolitan Sessions Judge-cum-I-Additional District and Sessions Judge, Visakhapatnam, in CrI.MP.No. 3873 of 2016 by relaxing the condition and release the petitioners/A-3 to A-5 on bail on executing a personal bond of Rs. 1,00,000/- [Rs. One Lakh only] each with two sureties for the like sum to the satisfaction of Judicial Magistrate of First Class, Madugula, Visakhapatnam district.

3. I hereby make it clear that all other conditions imposed by the I-Additional Sessions Judge, Visakhapatnam, shall remain in force for a period of three months or till filing of the charge sheet, whichever is earlier.

4. Accordingly, the order dated 17/11/2016 passed by the Metropolitan Sessions Judge-cum-I-Additional Sessions Judge, Visakhapatnam in CrI.MP.No. 3873 of 2016 is modified to the extent indicated above.

5. Accordingly, the Criminal Petition is allowed.

6. As a sequel, miscellaneous petitions if any, pending in this Criminal Petition shall stand closed.
