AUGUSTINE GEORGE MASIH, J. (Oral):

Learned counsel for the petitioners has argued the case at length but when this Court was not inclined to interfere in the matter on merits, he submitted that the petitioners who are in possession of the demised premises, may be granted time till 31.07.2017 to vacate the premises in question and they would hand over the vacant possession of the same to the respondent on or before 31.07.2017.

In view of the above, this revision petition stands dismissed on merits. However, as per the statement made by the counsel for the petitioners and without issuing any formal notice to the respondent to avert any further delay and the expenses which the respondent-landlord shall have to incur to defend these proceedings,

the petition is disposed of, in the following terms which have been accepted by the counsel for the petitioners:

1. The petitioners shall continue to occupy the demised premises up to 31.07.2017, if they are in possession thereof.
2. The entire arrears of rent, if any, shall be deposited by the petitioners with the Rent Controller, SBS Nagar, within a period of 15 days from today, failing which, the respondent shall be at liberty to execute the order of eviction, forthwith.
3. The petitioners shall continue to deposit the future rent by 7th day of every month with the Rent Controller, SBS Nagar. In the event of even a single default, the respondent-landlord shall be free to execute the order of eviction and obtain possession, forthwith.
4. The petitioners shall defray the electricity/ water charges for the period they would occupy the demised premises.
5. The petitioners shall vacate and hand over the actual and physical possession of the demised premises, free from all incumbrances, on or before the stipulated date i.e. 31.07.2017 to the respondent-landlord, failing which, respondent-landlord shall be free to execute the order of eviction.
6. The petitioners shall furnish an undertaking in the form of an affidavit in the above terms, with the Rent Controller/Executing Court, within a period of 15 days from today, failing which, the respondent-landlord shall be at liberty to execute the order of

eviction and obtain actual physical possession forthwith.

7. In case of violation of any of the undertaking(s), the petitioners shall render themselves liable to be proceeded against for contempt.

In view of the order passed in the the main revision petition, no separate order is required to be passed in this application for staying the operation of impugned orders as the same has been rendered infructuous.

Disposed of as such.
