For the reasons mentioned in the application, it is allowed and 241 days delay in filing the application for grant of leave to appeal stands condoned.

Heard learned counsel for the applicant.

A complaint was filed by the Municipal Council under Section 208 read with Section 233 of the Haryana Municipal Act, 1973 against the respondents for raising construction without sanctioned site plan.

It comes out that learned Chief Judicial Magistrate, Hisar vide impugned judgment dated 9.1.2015, held that the complaint is

not maintainable and the accused was acquitted from the charges levelled against him. Therefore, the same was dismissed.

I have gone through the judgment passed by the learned Chief Judicial Magistrate, Hisar. The learned Chief Judicial Magistrate, Hisar has given cogent reasoning in support of the judgment. Learned Magistrate has taken one of the two possible views.

It being so, there is no illegality or perversity in the same. Therefore, there is no ground to grant leave to file appeal and the same is dismissed.
