Present petition has been filed under Section 438 Cr.P.C seeking the concession of pre-arrest bail to the petitioner in case F.I.R. No.291 dated 24.9.2015 under sections 398, 401 I.P.C and sections 25, 54, 59 of Arms Act, registered at Police Station, Ambala City, District Ambala.

Counsel for the petitioner made a categoric submission at the bar that he has instructions to the effect that the observations contained in the order dated 14.10.2015, passed by the Court below declining the concession of anticipatory bail, are perverse and there is only one case pending against the petitioner as opposed to the observations contained in the order that there are 12 other criminal proceedings in which the petitioner was involved.

On the basis of such submission learned State counsel was called upon to complete instructions and a copy of the petition was furnished to him.

Learned State counsel, during the course of the day itself has completed instructions and has furnished to this Court a list of 13 other criminal proceedings in which the petitioner is involved. The details of

- 7. F.I.R No.116 dated 6.5.2002 under sections 307, 34 I.P.C and sections 25, 54, 59 of Arms Act, registered at Police Station, Mahesh Nagar, District Ambala.*
- 8. F.I.R No.34 dated 17.3.2002 under sections 302, 34, 201, 120-B I.P.C, registered at Police Station, Mahesh Nagar, District Ambala.*
- 9. F.I.R No.317 dated 26.11.2001 under sections 323, 325, 34 I.P.C, registered at Police Station, Mahesh Nagar, District Ambala.*
- 10. F.I.R No.122 dated 17.4.2000 under sections 332, 353, 34 I.P.C, registered at Police Station, Baldev Nagar, District Ambala.*
- 11. F.I.R No.112 dated 26.2.1999 under section 411 I.P.C registered at Police Station, Mulana, District Ambala.*
- 12. F.I.R No.86 dated 15.5.1999 under sections 399, 212 I.P.C registered at Police Station, Mulana, District Ambala.*

Conduct of the petitioner as also his past antecedents disentitles him to the concession of pre-arrest bail.

Accordingly, the present petition is dismissed.
