This order shall dispose of Criminal Misc.No.M-19912 of 2016, filed by petitioners Ramesh Kumar and Madhu and Criminal Misc.No.M-20865 of 2016, filed by petitioner Money under Section 438 Cr.P.C., for grant of anticipatory bail in case FIR No.77 dated 14.04.2016, registered at Police Station Salem Tabri, Ludhiana, under Sections 308, 323,

Criminal Misc.No.M-19912 of 2016(O&M)

341, 506, 34 IPC (Section 308 IPC added later).

At the very outset, learned counsel for the petitioners states that the interim bail was granted to the petitioner and they have joined the investigation.

Learned State counsel as well as learned counsel for complainant have, however, argued that injury falls under Section 308 IPC was attributed to petitioner Money.

In view of above, learned counsel for the petitioners states that he would not press the Criminal Misc.No.M-20865 of 2016 filed by petitioner Money and liberty may be granted to him to surrender before the Competent Court and move an application for grant of regular bail and a direction may be issued to the Court to decide the said application expeditiously.

Accordingly, Criminal Misc.No.M-20865 of 2016 stands dismissed as not pressed. In case, petitioner Money surrenders before the Competent Court on or before 15.11.2016 and moves an application for grant of regular bail, the same shall be decided expeditiously by the learned trial Court but in any case on or before 19.11.2016.

As regards Criminal Misc.No.M-19912 of 2016, the interim bail granted to petitioners Ramesh Kumar and Madhu is confirmed.

Accordingly, the Criminal Misc.No.M-19912 of 2016 stands allowed.
