Heard learned counsel for the rival parties.

Petitioner is in custody since 18.02.2016. Admittedly, challan has been filed before the competent Court. Though, the offences are serious in nature namely kidnapping of children for sale, but the fact that challan has already been filed, I think the petitioner should be granted the benefit of regular bail. But then, looking to the nature of offences petitioner has committed, she shall also have to file an undertaking on an affidavit that she will not commit similar or any kind of offence in future and if there any offence is committed, she would surrender to the custody.

In that view of the matter, this petition is allowed. The petitioner be released on bail to the satisfaction of the trial Court. Petitioner shall also file an undertaking on an affidavit before the trial Judge to the above effect.
