This order shall dispose of two petitions i.e. CRM-M-23914 of 2016 filed by Jaswinder Singh and others and CRM-M-38570 of 2016 filed by Sukhwinder Singh and others for quashing of FIR No.92 dated 14.07.2013 under Sections 307, 323, 427, 148, 149 IPC and 25, 27, 54, 59 Arms Act, 1959 and DDR No.22 dated 04.07.2013 under Sections 458, 336, 324, 148, 149 IPC 25, 27, 54, 59 Arms Act, 1959 registered at Police Station Bagha Purana, on the basis of compromise.

The original FIR was registered at the instance of Harpreet Singh alleging that on 02.07.2013 petitioners Jaswinder Singh and others armed with sharp edged weapons had attacked and fired upon the complainant party. Cross-version has been registered against Sukhwinder Singh etc. on the statement of Jaswinder Singh, having fired at them.

Parties were directed to appear before the trial Court to get their statements recorded regarding the compromise. After recording the statements of the parties, a report has been received to the effect that the matter has been compromised voluntarily, without any threat, coercion or undue influence.

In view of said circumstances and following the Full Bench judgment of this Court in **Kulwinder Singh and others Vs. State of Punjab and others 2007(3) R.C.R. (Criminal) 1052,** both the petitions are allowed. The aforesaid FIR as well as DDR and all the criminal proceedings emanating therefrom are hereby quashed on the basis of compromise.
