Applicants seek preponement of date of hearing of CM No.14227-CI-2015, seeking bringing on record legal representatives of Gurnail Singh (appellant No.4) and Surjit Kaur (appellant No.5), as the main case is covered by the order dated 8.1.2016 passed by this Court in RFA No.718 of 2000 (Jarnail Singh and others v. State of Punjab).

Notice of the application to the counsel opposite.

On the asking of Court, Mr.Yatinder Sharma, Addl.A.G., Punjab, accepts notice and fairly states that he has got no objection in case the present application is allowed.

In view of the above, present application is allowed, as prayed for. The date of hearing fixed in application bearing CM No.14227-CI-2015 is ordered to be preponed from 21.4.2016 to today.

On the asking of Court, Mr.Yatinder Sharma, Addl.A.G., Punjab, accepts notice and fairly states that he has got no objection in case both these applications are allowed.

After hearing the learned counsel for the parties, both these applications are allowed, however, subject to all just exceptions. Amended memo of pasties is also permitted to be taken on record.
