Petitioner is seeking transfer of investigation in case FIR No.05 dated 02.09.2015, under Section 376 IPC, registered at Police Station, Women Cell, Karnal, District Karnal (Annexure P-2), FIR No.879 dated 30.09.2015, under Sections 384, 389, 120-B IPC, registered at Police Station, City Karnal, District Karnal (Annexure P-4) and FIR No.611 dated 14.06.2016, under Sections 384, 389, 120-B IPC and Section 66 of the Information Technology Act, 2000, registered at Police Station, City Karnal, District Karnal (Annexure P-9) to some independent agency on the ground that the local police is not investigating the case fairly at the instance of private respondents.

Upon notice, reply on behalf of respondent No.4 by way of

affidavit of Deputy Superintendent of Police, City Karnal, has been filed, wherein it has been stated that in case FIR No.05 dated 02.09.2015, initially, the investigation was conducted by Sub Inspector Pawana Devi, who had recorded statements of the witnesses. Thereafter, further investigation was entrusted to State Crime Branch, Madhuban, Karnal by the Director General of Police, Haryana. After completion of investigation, challan has been presented on 10.02.2016 and the trial is fixed for evidence of prosecution.

In case bearing FIR No.611 dated 14.06.2016, an untraced report was prepared on 24.08.2016. Thereafter, on the direction given by the Superintendent of Police, Karnal, the matter has been sent for reinvestigation through the SHO Police Station, Women, Karnal. Now, the investigation is being conducted by Inspector Manisha.

In case FIR No.879 dated 30.09.2015, the investigation was entrusted to State Crime Branch, Madhuban, Karnal. After completion of investigation, challan has been presented against Gurmeet, Ram Rattan (complainant), Ram Karan (petitioner) and Angrej Singh on 30.07.2016. Now the trial is fixed for issuance of notice to the accused persons.

In view of the detailed reply filed by the Deputy Superintendent of Police, City, Karnal, no further orders are required to be passed in this petition.

Disposed of accordingly.
