The petitioner seeks grant of regular bail in case FIR No.847, dated 10.11.2015, registered under Sections 452, 384, 387, 506, 201, 120-B, 323, 364A, 511 of the IPC, at Police Station Sirsa City, District Sirsa.

Counsel for the petitioner has argued that apart from the merits of the case, the petitioner has now been in custody since 16.11.2015; his antecedents are clean and, therefore, should be released

on bail.

Counsel for the respondent, on instructions from SI Sushil, states that keeping in view the nature of the offence, instead of releasing the petitioner on bail, it would be appropriate to put a time cap on the trial since 13 witnesses who all are official witnesses remain to be examined. He has stated that the prosecution will lead its entire evidence on or before 11.11.2016 subject to the accused not obstructing the same.

Keeping in view the statement of counsel for the respondent, I dismiss this petition at this stage but direct the trial Court to release the petitioner on bail in case the prosecution fails to conclude the evidence on or before 11.11.2016 subject to the accused not obstructing the same.
