This batch of 19 appeals bearing RFA Nos.4686 to 4694 of 1998, 170, 2011, 3638 to 3642 of 1999 and 545 to 547 of 2000 is being decided vide this common order, as all these appeals arise out of same acquisition and raise identical issues. However, with the consent of learned counsel for the parties and for the facility of reference, facts are being culled out from **RFA No.4686 of 1998** (M/s Power Grid Corporation of India Ltd. through its General Manager v. Bhim Singh and others).

Detailed facts of these cases are not required to be noticed for the reason that learned counsel for the parties are *ad idem* that instant bunch of appeals is squarely covered by the order dated 14.12.2007 passed by this Court in **RFA No.872 of 1989 (Ganga Dan and others v. State of Haryana and another)**, which has been upheld by the Hon'ble Supreme Court vide its order dated 28.1.2015 passed in **Civil Appeal No.1884 of 2010 (Power Grid Corporation of India Ltd. v. Ganag Dhan (D) by LR's and others)**. They jointly pray for disposal of these appeals in terms of the order dated 14.12.2007 passed by this Court in **Ganga Dan's** case (supra) and also the order dated 28.1.2015 passed by the Hon'ble Supreme Court.

After hearing the learned counsel for the parties, all these appeals have been found squarely covered by the order dated 14.12.2007 passed by this Court in **Ganga Dan's** case (supra), which has been upheld by the Hon'ble Supreme Court vide its above-said order dated 28.1.2015. Accordingly,

all the above-said appeals are ordered to be disposed of, in terms of the order dated 14.12.2007 passed by this Court in **Ganga Dan's** case (supra), which has been upheld by the Hon'ble Supreme Court vide its order dated 28.1.2015 passed in Civil Appeal No.1884 of 2010.

Disposed of, accordingly.
