Heard learned counsel for the rival parties.

In FIR No.120 dated 24.08.2015, under Sections 17, 18, 29 of Narcotic Drugs and Psychotropic Substance Act, 1985 and Section 3 of the Prevention of Damage to Public Property Act, 1984, registered at Police Station Odhan, District Sirsa, petitioner was arrested on 24.08.2015 and is in Jail since then.

Learned State counsel submits that the evidence against the petitioner is that he was having cash in the sum of ₹4 lacs and was waiting in the Car.

Prima-facie, in my opinion, the petitioner deserves to be granted the benefit of bail.

In that view of the matter, this petition is allowed.

Petitioner be released on bail subject to the satisfaction of the learned

Chief Judicial Magistrate/Duty Magistrate concerned. Petitioner shall not tamper with the prosecution evidence or threaten the prosecution witnesses.
