The petitioner seeks concession of regular bail under Section 439 of the Code of Criminal Procedure, in case FIR No.15 dated 12.01.2016, registered under Section 21/22 of the NDPS Act, at P.S. Sadar Ferozepur.

The learned counsel for the petitioner submits that the petitioner is in custody since 15.01.2016. Till today, the FSL report has not been filed.

The learned State counsel, on instructions, states that despite repeated reminders, to the concerned authorities, the report has not so far been received. Further, there is no assurance on behalf of the State as to how soon the same could be furnished.
