This order shall disposed of aforesaid five petitions filed by the petitioners under Section 438 Cr.P.C., for grant of anticipatory bail in case FIR No.91 dated 27.07.2016, registered at Police Station Khamano, Fatehgarh Sahib, under Sections 452, 323, 324, 336, 148, 149, 506 and 326 IPC (Section 326 IPC added later) and in cross case i.e. DDR No.20 dated 28.07.2016 registered under Sections 326, 323, 324, 506, 34 IPC as parties on both sides are before this Court.

It is stated that some accused persons from both sides have been granted the concession of anticipatory bail and, therefore, learned counsel appearing from both sides of the petitioners pray that bail be granted to the petitioners.

Learned State counsel, on instructions from ASI Dharam Pal, has accepted that some accused persons from both sides have been granted anticipatory bail.

In this view of the matter, I see no reason to take different view. Consequently, all the petitions stand allowed. Petitioners are directed to

appear before the concerned Investigating Officer on 29.09.2016 between 10.00 am. to 04.00 p.m. and on any other day when concerned Investigating Officer requires their presence and would otherwise cooperate with him/her. On appearance, the petitioners be released on bail subject to their furnishing personal bonds and surety to the satisfaction of Arresting/Investigating Officer. However, the petitioners shall abide by the conditions as provided under Section 438 (2) Cr.P.C.
