This petition under Section 438 of the Code of Criminal Procedure has been filed for grant of pre-arrest bail to the petitioner in FIR No.252 dated 25.07.2015 registered under Sections 188, 290, 336 and 308 read with Section 34 of Indian Penal Code (in short 'IPC') at Police Station DLF, Phase-I, Gurgaon, District Gurgaon.

Learned counsel contends that petitioner was admitted to regular bail. Thereafter, he had been regularly appearing. However, the petitioner could not cause representation as he was held up in traffic jam due to heavy rain. The petitioner did not misuse the concession of bail and he was not arrested from the spot. The absence from the Court is not deliberate and intentional.

Notice of motion.

At the asking of the Court, Mr. Saurabh Mohunta, DAG, Haryana, accepts notice on behalf of the respondent-State. A complete copy of the paper book has been furnished to the learned State counsel, in the Court.

In the circumstances, in case the petitioner surrenders within three weeks from today, he be admitted to bail on furnishing fresh bail bonds and surety bonds to the satisfaction of the trial Court.
