This petition has been taken up on the judicial side pursuant to an application made by Surender Kaur to the effect that despite giving a written information along with CD to the Women Cell, Ambala, no action has been taken against the accused persons.

Upon notice, reply on behalf of respondents, by way of affidavit of Superintendent of Police, Ambala, has been filed, wherein it has been stated that a case FIR No.93 dated 17.09.2016, under Sections 147/149/323/342/355/500/501/504/506/509/34 IPC, Police Station Panjokhra has been registered on a complaint made by Saravjeet Singh son of Inder Singh, resident of H.No.97/1545, Baldev Nagar, Ambala City. Petitioner-Surinder Kaur was joined in the investigation on 27.09.2016 and her statement was recorded under Section 161 Cr.P.C. Thereafter, supplementary statement of Saravjeet Singh was recorded, pursuant to which, he handed over a CD to the Investigating officer, which was taken into possession vide recovery memo dated 27.09.2016. Parents of Surinder

Kaur, namely Tara Chand and Reshma were also joined in the investigation

and their statements were recorded by the Investigating Officer. On 29.09.2016, accused Amit Kumar @ Ladi and Jagwinder Singh @ Firangu were arrested and they both suffered disclosure statements to the effect that Saravjeet Singh was having illicit relation with a woman of their village namely Surinder Kaur wife of Sukhwinder Singh and their relation was not acceptable to the villagers. In a pre-planned manner, they caught Saravjeet Singh on 26.08.2016 when he was coming from Baldev Nagar side on his motorcycle. They manhandled Saravjeet Singh. Surinder Kaur was also forcibly taken from her house to the spot and was beaten up. On 30.09.2016, accused Malkit Kaur and Jaswinder Kaur were arrested in this case. Similar disclosure statements were made by them. On 05.10.2016, accused Krishna Devi surrendered herself before the Court. Thereafter, she was joined in the investigation. Accused Balbir Singh @ Gola Panch and Harjeet Singh, Sarpanch, were joined in the investigation on 08.10.2016. They were formally arrested and released on interim bail. Investigation in the case is still going on.

The main grievance of the petitioner was that the police was not taking any action against the accused persons. However, as per reply filed, now an FIR has been registered and the accused have been arrested. Therefore, grievance of the petitioner stands redressed. Accordingly, no further orders are required to be passed in this petition.

Disposed of accordingly.
