This order shall dispose of RFA Nos. 126, 127, 74, 66, 82, 71, 78, 79, 72, 77, 81, 69, 75, 83, 65, 76, 73, 70, 68, 64, 80 and 84 of 2004.

Learned counsel for the appellant submits that the matter in issue is squarely covered by the judgment dated 21.05.1987, rendered by this court in RFA No.440 of 1986 (Zora Singh and others Versus Union of India and others), and other connected matters, vide which in the appeals arising out of the same acquisition this Court had enhanced the compensation awarded to the landowners. And, an appeal preferred against the said judgment by the appellant (Union of India), LPA No.1251 of 1987, was dismissed by the Division Bench on 30.01.1989. So much so, even the SLP filed by the appellant against the order dated 30.01.1989, passed by the LPA Bench (Union of India and another Vs. Zora Singh etc.) also stands

dismissed on 22.11.1991, by the Hon'ble Supreme Court. Therefore, he submits that the present appeals being squarely covered by the afore-indicated decisions shall meet the same fate.

Accordingly, the appeals are dismissed.
