Learned counsel for the petitioners states that petitioner No.2 is of 17 years and 07 months and residing with the family of petitioner No.1 with her own sweet free will. They have solemnized marriage. He cites '**Neelam Rani and others Vs. State of Haryana and others**', 2011 (1) **RCR (Civil) 636**, to contend that the petitioner No.2 has reached the age of discretion. Their marriage is opposed by respondent Nos.4 to 6.

Notice of motion.

At the asking of the Court, Ms. Harsimrat Rai, DAG, Punjab, accepts notice on behalf of the respondent-State. A complete copy of the paper book has been furnished to the learned State counsel, in the Court.

Without expressing any opinion with regard to validity of marriage and on the merits of the assertions made in the petition, the instant petition is disposed of with the direction to respondent No.2- Senior Superintendent of Police, Bathinda to take necessary action on the representation dated 04.11.2016 (Annexure P-4) moved by petitioner No.1

and provide necessary protection to the petitioners in accordance with law in case he is satisfied that the life and liberty of the petitioners is threatened at the hands of respondent Nos. 4 to 6.
