This order will dispose of three applications, one filed by Kalyan Singh @ Silly and others (CRM-M-43321-2015), second filed by Jaswinder @ Jassi (CRM-M-4987-2016) and third filed by Banti @ Suraj (CRM-M-5877-2016) for pre-arrest bail.

The FIR was registered at the instance of Shantanu Kumar alleging that on 29.10.2015 the petitioner constituted an unlawful assembly waylaid complainant by approaching him in two different cars. The petitioners attacked Anurag and Vicky armed with weapons like sword, baseball bats and rods etc. and attempt was made to kidnap Anurag by putting in the car. Anurag received baseball bat injuries on the legs. Raj Kumar is not attributed any specific injury. Mehul Dutt gave a danda blow

on the shoulder of Anurag. Jaswinder gave a danda blow on the leg of Anurag. Banti is attributed a sword blow on the legs of Anurag resulting in a sharp injury..

State counsel has submitted that on the basis of record that injury attributed to Banti with sword on the legs of Anurag is grievous injury.

I have considered the roles attributed to the petitioners. Anurag had total 11 injuries. Remaining most of the injuries are simple injuries. The application of Banti @ Suraj and Kalyan Singh @ Silly is hereby dismissed. Interim order qua them is hereby vacated.

However, application of Raj Kumar, Mehul Dutt and Jaswinder @ Jassi are allowed. These petitioners are ordered to be released on bail in the event of their arrest, to the satisfaction of the arresting officer subject to the conditions that the petitioners will join investigation as and when required and will not tamper with the evidence or hamper investigation in any manner.
