2. On January 06, 2016, the following order was passed by this Court:-

“At the very outset, learned counsel for the petitioner contends that in view of the concurrent findings of both the Courts below, he does not want to challenge the conviction of the petitioner. However, he submits that in view of the circumstances of the case, the sentence awarded by the Courts below is on higher side.

Notice of motion for 04.03.2016 with regard to quantum of sentence only”.

3. Learned counsel for the State submits that the present criminal revision petition can be disposed of at this stage in view of the submission of learned counsel for the petitioner. This Court is also of the considered opinion that in view of the contention of the learned counsel for the petitioner and the stand taken by learned counsel for the State, the present petition can be disposed of at this stage.

4. Here it would be pertinent to mention that petitioner did not challenge his conviction on merits and only confined his relief qua quantum of sentence. This Court has also scrutinized the impugned judgments as well as the relevant documents/evidence and is of the considered view that there is no scope for any interference in impugned judgment(s) as far as the conviction of the petitioner is concerned. As such, the conviction of the petitioner is upheld.

5. As far as quantum of sentence is concerned, there are mitigating circumstances to take a lenient view in the matter of sentence awarded by the trial court and upheld by the lower appellate court. Apart from the fact that

petitioner is facing the agony of protracted trial for the last more than 8 years after registration of the instant case, he is the only bread winner in the family and belongs to a poor family. Accused – petitioner is first offender. There is no other case of similar nature, either pending or disposed of, against the petitioner. Moreover, petitioner has already suffered incarceration for a period of 01 years 05 months and 25 days as on March 04, 2016 and he never misused the concession of bail, which shows that he is in process of improving himself, therefore, some concession in substantive sentence can be extended to him. Thus, this court is of the considered view that a chance be given to the petitioner to reform & improve himself; to become a good citizen; and to lead a peaceful & harmonious life.

6. Taking into consideration the above narrated discussion as well as the fact that petitioner has not challenged his conviction on merits, while affirming his conviction, the order of sentence is modified to the extent to the period already undergone by him with no change in the fine clause.

7. With the aforesaid modification in the quantum of sentence, the revision petition stands dismissed.
