Learned counsel for the parties are ad idem that the matter in issue is squarely covered by the order/judgment dated 27.2.2015 rendered by this court in RFA No.4241 of 2006 (**Vijay and another versus State of Punjab and others and other connected matters**) vide which in the appeals arising out of the same acquisition, this court had enhanced the compensation to Rs.110/- per sq. yard. Therefore, it is submitted that the appeals as also cross-objections, preferred by the appellants-land-owners shall have to be disposed of in terms of the decision of this court in the case of **Vijay and another**, whereas the appeals preferred by the beneficiary of the acquisition, i.e., the Punjab Small Scale Industries and Export Corporation or the State shall have to be , necessarily, dismissed.

Ordered accordingly.
