Vide this common order above mentioned two petitions are
being disposed of.

Criminal writ petition has been filed under Article 226 of the
Constitution of India for issuance of a writ of Habeas Corpus for
appointment of a warrant officer to raid the house of the respondent No.4
and 5 and to recover the detainee Sumanpreet Kaur i.e wife of the petitioner

from illegal custody and further directions be issued to the official respondents to produce the detainee.

Second Criminal Miscellaneous petition has been filed under Section 482 of the Cr.P.C. is for issuance of a direction to the official respondents to protect the life and liberty of the petitioners and not to harass them at the instance of respondent Nos.4 and 5.

Reply by way of affidavit of Harkamalpreet Singh Khakh, PPS, Senior Superintendent of Police, District Amritsar(Rural) in compliance of order dated 17.10.2016 has been filed. The same is taken on record. Copy has been supplied to the opposite party. It is averred that actually the parents of the boy were arrested on 02.10.2016 and the girl Sumanpreet Kaur was presented before the Magistrate on 03.10.2016. Learned counsel for the petitioner is not in a position to deny this.

In these circumstances, the assertion made that Sumanpreet Kaur was picked up from the pass-counter of the High Court does not seem to be correct. No further action is required. On the last date of hearing Sumanpreet Kaur was permitted to go with Lovepreet Singh. That order is reiterated.

Both cases stand disposed of.
