It was not disputed by the learned counsel for the parties that total tax and interest payable as determined by the Assistant Commissioner of Income Tax, Circle-IV, Amritsar, was ₹12,96,954/-. In such circumstances, it was not controverted by learned counsel for the appellant that the case is covered by the circular No.21 of 2015 dated 10.12.2015, issued by the C.B.D.T., New Delhi, as the tax effect is less than ₹20 lacs. Therefore, in view of the aforesaid circular, the present appeal may be dismissed as withdrawn. However, liberty be granted to the revenue to file an application for revival of the appeal in case something survives therein.

2. Dismissed as withdrawn with liberty as prayed for. It is, however, clarified that withdrawal of the appeal by the revenue shall not be taken to be affirmation of order of the Tribunal on merits. Further, the legal issue as claimed by the revenue is being left open to be adjudicated in an appropriate case.
