**By way of this order we shall dispose of *CWP-10372-2015*,
CWP-16210-2015 and *CWP-19724-2015* as they relate to the same
controversy.**

Counsel for the State of Haryana has filed an affidavit of Suprabha Dahiya, IAS, Transport Commissioner, Haryana. A relevant extract from the affidavit reads as follows:-

3. *That in compliance of the above orders of this Hon'ble Court, the draft of the Stage Carriage Scheme revisiting the State Carriage Scheme of 2013 notified on 12.08.2013 as per orders of Hon'ble High Court dated 28.10.2014 in CWP-20869 of 2013 and other connected matters was placed before Council of Ministers (CMM) in its meeting held on 03.02.2016 after getting it approved from the Government. The scheme was also got vetted from Ld. LR, Haryana and the concurrence of FD has also been obtained. The proposed draft Scheme has been approved by the Council of Ministers. A copy of the approval of the CMM is annexed herewith as Annexure R-1.*
4. *That the draft of the Scheme is likely to be got published within two weeks after receipt of the opinion of the Advocate General, Haryana.*

Accordingly, the aforementioned writ petitions have been rendered infructuous and are disposed of by directing the State of Haryana to positively notify the draft scheme within fifteen days from today.
