This order of mine shall dispose of bunch of writ petitions bearing ***CWP Nos.11366 of 2016, 11818 of 2016, 12457 of 2016, 13570 of 2016, 13872 of 2016, 14098 of 2016, 14478 of 2016, 14512 of 2016, 14785 of 2016, 14954 of 2016, 14968 of 2016, 16167 of 2016, 17111 of 2016, 17562 of 2016, 18243 of 2016, 18375 of 2016, 18490 of 2016, 19380 of 2016, 20965 of 2016, 17549 of 2016, 17727 of 2016, 22486 of 2016, 17595 of 2016, 22152 of 2016, 22162 of 2016, 22429 of 2016, 21948 of 2016, 25660 of 2016, 23502 of 2016 and 18289 of 2015*** as common question of law and facts are involved in all these cases.

As per order passed by this Court on 11.11.2016, the respondents were directed to consider the objections filed by the petitioners and other similarly situated candidates regarding tentative seniority list within a period of three weeks from the date of receipt of certified copy of the order.

Learned counsel for the petitioners submits that the objections of the petitioners and other candidates were considered and final seniority list-District wise has been released.

A direction was also issued to the respondents-State to place on

record the final seniority list and the petitioners, if aggrieved, were at liberty to challenge the same.

Learned State counsel submits that the copy of revised seniority list has not been placed on record and the petitioners may apply for the same.

Keeping in view the facts as mentioned above, the present petition is disposed of.

However, in case, any application is moved by the petitioners or any other candidate(s), the respondents are directed to supply the copy of said revised seniority list to them within a period of two weeks thereafter with a liberty to the petitioners to challenge the same, if they are aggrieved in any manner.

It is also mentioned that in case, the petitioners and other similarly situated persons challenge the seniority list within a period of three weeks from today, the respondents are directed not to make any promotions.
