5681 of 2016, *Anmol Kaur Gill and another vs. UOI and others* (Ist petition), **CWP NO. 6325 of 2016**, *Pravesh and others vs. UOI and others* (IIInd petition), **CWP No. 6683 of 2016**, *Anjali Ahuja vs. UOI and others* (IIIrd petition), **CWP No. 6814 of 2016**, *Kritika and others vs. UOI and others* (IVth petition), **CWP No. 6930 of 2016**, *Divya Savy vs. UOI and others* (Vth petition) and **CWP No. 9791 of 2016**, *Preeti Bhati and others vs. Union of India and others* (VIth petition) by this common order as the prayer made in these petitions is identical. However, for the sake of convenience, the facts are being extracted from the Ist petition.

The petitioners are the students of MBBS in Gold field Institute of Medical Science and Research(the College) studying in various years, have prayed that a direction to the respondents be issued to allocate them medical colleges in the State of Haryana affiliated to Pt. B.D.Sharma University of Health Science, Rohtak because their college has become non-functional.

Shri Puneet Gupta, Counsel for Union of India has informed the Court that the State Government has withdrawn the Essentiality Certificate and has decided to shift the students of the college to other medical colleges in the State of Haryana for which the MCI had already given approval on 15.05.2016 on the basis of recommendations of the State government forwarded to it on 29.04.2016. Since the decision has already been taken by the MCI for shifting of the petitioners to other medical colleges both the government as well as private in the State of Haryana for which the counseling is already fixed for 30.05.2016 and 31.05.2016. therefore, these petitions have become infructuous as the relief sought in this petition have

already been granted by the respondent State and the Union of India.

Consequently, these petitions are hereby disposed of as having been rendered infructuous.
