This is an application to list the main case, for the appeal arising out of the same acquisition has since been decided by this Court, vide judgement dated 12.02.2016, rendered by this Court in **RFA No.1427 of 2014** titled “Rajit and another versus State of Haryana and others”.

For the reasons set out in the application, that is duly supported by an affidavit, same is allowed, subject to all just exceptions. Consequently, legal representatives of deceased Desh Ram son of Ram Nath, who is stated to have died on 09.12.2001, are brought on record for

the purpose of pursuing the present appeal only.

CM stands disposed of.

CM No.9186-CI of 2016

For the reasons set out in the application, that is duly supported by an affidavit, same is allowed, subject to all just exceptions. Consequently, legal representatives of deceased Bohati wd/o Hans Ram, who is stated to have died on 02.01.2011, are brought on record for the purpose of pursuing the present appeal only.

RFA No.3330 of 2016

For, the learned counsel for the parties are ad idem that the matter in issue is squarely covered by the decision rendered by this court in Rajit's case (Supra), vide which this Court had enhanced the compensation awarded to the landowners, this appeal is disposed of in terms thereof.
