This is an application for condonation of delay of 1187 days in filing the accompanying appeal.

All what has been urged by learned counsel for the applicants is that the matter in issue is squarely covered by the judgment, dated 01.09.2014, rendered by this court in RFA No.2250 of 2011 [**Risal Singh v. State of Haryana and another**], vide which in the appeals arising out of the same acquisition, this court had enhanced the compensation awarded to the landowners.

Notice qua respondents No.1 & 2 only, for the rest of the respondents are stated to be the merely proforma respondents.

Mr. Shivendra Swaroop, AAG, Haryana, present in court, accepts notice on behalf of respondents No.1 & 2.

The factual position, as set out above, is not disputed by learned State counsel.

I have heard learned counsel for the parties and perused the record.

In the wake of the decisions of the Hon'ble Supreme Court in Imrat Lal and others v. Land Acquisition Collector and others, 2015(2) RCR (Civil) 437 and Dhiraj Singh (D) Tr. LRs. v. Haryana State and others, 2015 (2) RCR (Civil) 507, delay of 1187 days in filing the accompanying appeal is condoned. However, for the period of delay the applicants shall not be entitled to interest on the enhanced compensation.

CM stands disposed of.

CM-10952-CI-2016

For the reasons set out in the application, the delay of 671 days in re-filing the accompanying appeal is condoned.

CM stands disposed of.

CM-10953-CI-2016

For the reasons set out in the application, which is duly supported by an affidavit, the same is allowed subject to all just exceptions. Consequently, leave is granted to the LRs of late Nafe Singh (appellant No.8), who is stated to have passed away during the pendency of the reference on 30.07.2010, to institute and maintain the present appeal.

RFA-3966-2016

For, the learned counsel for the parties are *ad idem* that the matter in issue is squarely covered by the decision rendered by this court in Risal Singh's case (supra), the present appeal is disposed of in the same terms. However, the appellants shall not be entitled to interest for the period of delay in filing the appeal i.e. 1187 days.
