RAMESHWAR SINGH MALIK, J. (Oral)

Applicant-wife, by way of instant transfer application under Section 24 of the Code of Civil Procedure, seeks transfer of a divorce petition, filed by the respondent-husband from Ambala to Yamuna Nagar.

Notice of motion was issued and in the meantime further proceedings before the learned trial Court at Ambala were stayed.

Learned counsel for the respondent put in appearance on the last date of hearing, but no one has come present today on behalf of the respondent despite the fact that case has been called twice over.

Heard learned counsel for the applicant.

It has gone undisputed before this Court that there is one child out of this wedlock. Applicant-wife along with her minor child is staying at her ancestral village in District Yamuna Nagar. Neither the applicant-wife is having any regular source of income nor the respondent-husband is paying any amount of maintenance either for the applicant-wife or for the minor child. Distance between Yamuna Nagar and Ambala is about 50 kilometers.

In view of the above-said undisputed fact situation obtaining in the present case, this Court feels no hesitation to conclude that the instant transfer application deserves to be allowed. It is so said because financial status of the wife, her responsibility for bringing up the child, her source of income, conduct of the respondent-husband in not paying any amount of

maintenance and distance between two places, besides her convenience, are some of the relevant considerations for deciding the transfer application, like the present one.

The abovesaid view taken by this Court also finds support from the order dated 16.3.2016 passed by this Court in **TA No.945 of 2015 (Sushma and others v. Kapil @ Sahil Bansal)**, which in turn, was based on the judgments of the Hon'ble Supreme Court, as well as different High Courts, including this Court.

No other argument was raised.

Considering the peculiar facts and circumstances of the case noted above, coupled with the reasons aforementioned, this Court is of the considered view that the instant transfer application deserves to be accepted and the same is hereby allowed. The above-said divorce petition, filed by the respondent-husband, is ordered to be transferred from Ambala to Yamuna Nagar.

Accordingly, learned District Judge, Ambala, is directed to send the complete record of the above-said petition to the learned District Judge, Yamuna Nagar, at an early date and in any case within a period of one month from the date of receipt of a certified copy of this order.

Learned District Judge, Yamuna Nagar, is also directed either to decide the case himself or assign it to the learned court of competent jurisdiction for its early decision, in accordance with law.

With the above-said observations made and directions issued, the instant transfer application stands disposed of.
