Instant application under Section 24 of the Code of Civil Procedure has been filed seeking transfer of civil suit No.274-A dated 5.6.2010 (RT No.1670 dated 01.07.2013/RT No.274 dated 17.07.2014), Computer Filing No.030300016702010, titled as 'Tejinder Singh and others vs. Ram Partap Puri and another' (Annexure P-1) from the Court of Sh. Amit Thind, learned Additional Civil Judge (Sr. Divn.), Kapurthala to the Court of learned Civil Judge (Sr. Divn.), Ludhiana where civil suit No.2500 of 2013, registration No.35650/2013 and Code No.200400025002013 was pending for 22.01.2015 with regard to the same property.

I have heard learned counsel for the parties and perused the record.

Learned counsel for the applicant contends that the applicant is 76 years old. A civil suit filed by the applicant with regard to same property has already been transferred from Kapurthala to Ludhiana vide order dated 09.05.2011 passed by a Coordinate Bench of this Court. The applicant is unable to attend the court on every date at Kapurthala.

Per contra, learned counsel for respondent No.1 vehemently opposes the contentions of learned counsel for the applicant and contends that the applicant being defendant in civil suit is not required to appear on each and every date in the Court at Kapurthala.

I have considered the rival contentions of learned counsel for the parties.

Admittedly, on the application moved by the applicant being plaintiff, civil suit No.2500 of 2013, registration No.35650/2013 and Code No.200400025002013 has been transferred from Kapurthala to Ludhiana vide order dated 09.05.2011 passed by a Coordinate Bench of this Court. The applicant has now approached this Court for transfer of the another civil suit (Annexure P-1) on the ground that it is also with regard to the same very property. In view of above and in order to avoid any conflict of judicial opinion, application is allowed. Civil Suit (Annexure P-1) is withdrawn from the Court of Sh. Amit Thind, learned Additional Civil Judge (Sr. Divn.), Kapurthala and is transferred to the Court of learned Civil Judge (Sr. Divn.), Ludhiana where civil suit

No.2500 of 2013, registration No.35650/2013 and Code No.200400025002013 is pending. It is made clear that both the suits shall be decided by one court so that issue of conflict of decision does not arise. The entire record of civil suit (Annexure P-1) shall be sent to the transferee court immediately. Learned counsel for the applicant states that civil suit is pending before the concerned court at Ludhiana for 04.02.2016. The parties through their counsel are directed to appear before the transferee court on 04.02.2016.
