S.S. SARON, J.

The petitioner has been convicted and sentenced to life imprisonment in case FIR No.169 dated 06.06.2009, registered at Police Station Sadar Thanesar, District Kurukshetra for the offences under Sections 307, 398, 401, 420, 467, 468, 471, 411 of the Indian Penal Code, besides, Section 25 of the Arms Act. Against the said order of conviction and sentence, criminal appeal, i.e. CRA-D No. 1181-DB of 2013, is pending in this Court.

A petition was filed by the petitioner for temporary release in terms of the Haryana Good Conduct Prisoners (Temporary Release) Act, 1988. The said petition was disposed of by this Court vide order dated 02.11.2015 directing the Commissioner, Ambala Division, Ambala (respondent No. 3) to consider the case of the petitioner for grant of parole

as expeditiously as possible and preferably within a period of four weeks from the date of receipt of certified copy of the order.

The Commissioner, Ambala Division, Ambala has disposed of the case on 24.02.2016. The order that has been passed is quite dim. However, the office noting shows that the Commissioner, Ambala Division, Ambala has concluded in her order that it has been found that the convict (petitioner) is undergoing imprisonment in District Jail, Nabha in case FIR No. 235 of 2009, registered at Police Station Sector 34, Chandigarh. The sentence in case FIR No.169 dated 06.06.2009, registered at Police Station Thanesar, District Kurukshetra, in which directions were issued, will start after completion of sentence in the case registered at Police Station Sector 34, Chandigarh. A sentence of seven years' imprisonment has been imposed on the petitioner in the case registered at Chandigarh which has commenced from 14.08.2013. It is after completion of sentence in the said case, the sentence in present FIR No.169 dated 06.06.2009 registered at Police Station Sadar Thanesar, District Kurukshetra would commence.

Learned counsel for the petitioner submits that in the circumstances he does not press the present petition any further and he would file a petition for temporary release of the petitioner in the case registered at Sector 34, Chandigarh.

The petition is disposed of accordingly.
