The private parties involved in the above FIRs are relatives of each other. Mr. Satish Chopra and Mr. Kapil Chopra are brothers. Smt. Raj Chopra is their mother. Smt. Poonam Chopra is wife of pre-deceased brother of Mr. Satish Chopra and Mr. Kapil Chora. Mr. Karan Chopra is son of Mr. Satish Chopra and Mr. Rahul Chopra is son of Mr. Kapil Chopra. Disputes arose between them in respect of their shares in the family properties and businesses, which led to filing of the various civil cases as well as lodging of above referred FIRs by one party against other. The parties have now settled their disputes, be it civil or criminal, vide Memorandum of

Understanding dated 31st July, 2013 along with Addendum to Memorandum of Understanding dated 31st July, 2013 executed on 30th March, 2015. A decree in CS(OS) No.2438/2014 has already been passed on 10th April, 2015 in terms of the compromise application being I.A. No.7118/2015 coupled with Memorandum of Understanding dated 31st July, 2013 and Addendum dated 30th March, 2015. Complainant/R-2 in all the above referred FIRs are present in Court and have submitted that FIRs be quashed in view of the settlement.

Keeping in mind the facts that disputes involved in the above referred FIRs relate to the family members and that they have settled their disputes amicably, in order to maintain harmonious relations in future, inasmuch as, civil suit has been decreed by accepting the compromise, no fruitful purpose would be served to keep them entangled in the present criminal proceedings. Accordingly, in the interest of justice, all the above referred FIRs, which are pending investigations, are quashed.

Writ petitions are disposed of in the above terms. Miscellaneous applications are disposed of as infructuous.
