Other terms and conditions have also been stated in the statement. The statement is taken on record. The said petitioners shall remain bound by the said statement.

Learned counsel for the petitioners submits that the other co-petitioners, namely, Smt. Ramesh Gupta, Smt. Sudha Gupta, Sh. Gaurav Gupta, Ms. Puja Gupta and Ms.Manju Gupta shall also remain bound by the statement made today by petitioners No.1 and 3. She submits that as a

precaution, the affidavits of the other petitioners giving an undertaking to vacate the premises in question on or before 30.06.2018 as per the statement made in court by Smt. Meera Gupta, petitioner No.1 and Sh. Anup Gupta, petitioner No.3 shall also be filed within two weeks from today.

In view of the above, the learned senior counsel appearing for the respondent submits that the respondent shall not execute the eviction order till 30.06.2018.

The petition stands disposed of in terms of the above.
