It is submitted that matter has been settled before the mediation centre for ₹22 Lakhs, inasmuch as, ₹3,50,000/- has already been paid to complainant. SI Rajender Prasad PS Maya Puri is present in Court and submits that complainant has admitted having received ₹3,50,000/- vide demand draft.

Keeping in mind the above facts, it is ordered that in case of arrest, petitioners be redeemed on bail, subject to his furnishing a personal bond in the sum of ₹25,000/- (Rupees Twenty Five Thousand Only) each with one surety of like amount each to the satisfaction of Investigation Officer/Arresting Officer/SHO concerned. Petitioners shall, however, co-operate in the investigations and appear before Investigation Officer as and when required to do so. Bail application is disposed of in the above terms.
