5. 11-01-2017 At the very outset, Sri Vipin Kumar, learned counsel appearing on behalf of Magadh University, in presence of Sri Pramod Kumar Sinha, learned counsel for the petitioner and learned A.C. to Standing Counsel – 16, by way of referring to fact disclosed in the show cause, submits that in compliance with the order of the writ court, the representation of the petitioner was
