3 21-11-2017 This application has been filed for seeking quashing of then Government notification No. 1493, dated 16.10.2017, whereby Mr. Vijay Kumar Pandey, Joint Director, Secondary Education, Government of Bihar, Patna was appointed as appellate authority under Bihar Madrasa Education Board Act, 1981 (hereinafter referred to as the Act).
