In view of the law laid down by the Supreme Court in the case of **Bholanath Mukherjee & Others – Versus- Ramakrishna Mission Vivekananda Centenary College & Others** [(2011) 5 SCC 464] and followed recently by the Delhi High Court in the case of **Forum of SC and ST Legislators and Parliamentarians –Versus- Oil and Natural Gas Corporation Ltd & Another (WP (C) No 1698 of 2017)** decided on 27.02.2017, in a public interest petition, service
