ORAL ORDER

31 08-11-2017 The issue involved in all these contempt applications pertains to payment of salary to the petitioners and their grievance with regard to non-compliance with the orders passed in various writ petitions filed by them, all these contempt applications were filed and the matters are pending since 2007. The matters were kept pending before this Court in view of the fact that S.L.P. (Civil) No. 12591 of 2010 was pending before the Hon'ble Supreme Court. S.L.P. (Civil) No. 12591 of 2010 was allowed and thereby C.A. No. 002703 of 2017 was registered before the Hon'ble Supreme Court and a Bench of the Hon'ble Supreme Court by a detailed order passed on 31.08.2017 has disposed of the Civil Appeal giving various directions and modifying certain observations and orders passed in the writ petition.

Now, in view of the aforesaid order passed by the Hon'ble Supreme Court on 31.08.2017 in C.A.No. 002703 of 2017 some of the applicants may be entitled to some benefits and some of the applicants may not be entitled to any benefit.



Be it as it may, the rights, liabilities and the benefit available to the parties before me in these contempt applications is now required to be worked afresh in the light of the order passed by the Supreme Court and, therefore, no further action is required to be taken in these contempt applications, instead, parties are granted liberty take note of the order passed by the Hon'ble Supreme Court, evaluate the rights and liabilities available to them and raise their respective claim or ventilate their grievance afresh in accordance with law by approaching the appropriate forum as may be permissible under law.

With the aforesaid liberty to the parties, for the present, finding no case made out for making any further indulgence in these proceedings, all these contempt applications stand disposed of.
