ORAL JUDGMENT

Date: 22-02-2017

The petitioner has sought initiation of contempt proceedings for violating the orders and directions issued by the Hon'ble Supreme Court in the case reported as D.K. Basu Vs. State of W.B., (1997) 1 SCC 416.

In the counter affidavit, it is *inter alia* averred that the petitioner is resident of Nepal and is an accused in many criminal cases and has filed number of writ applications as well. It is pointed out in the counter affidavit filed by Shyamdeo Mahto, that he is



discharging his duty lawfully but the petitioner has filed series of false and frivolous cases so that investigations are not done properly.

Learned counsel for the State points out that departmental proceedings have been initiated against Respondent No. 8. Thus, I find that no further action is required in the present Contempt Petition. The same is disposed of.
