ORAL ORDER

5 25-07-2017 Heard learned counsel for the petitioners and the learned A.P.P. for the State.

The petitioners apprehend their arrest in connection with Bhorey P.S. Case No. 144 of 2016, registered under Section 304(B)/34 of the Indian Penal Code.

The accusation is of killing the daughter of the informant by her husband and in-laws due to non-fulfillment of demand of dory by putting fire after sprinkling kerosene oil.

Learned counsel for the petitioners submits that petitioners are brother-in-law, sister-in-law, married sister-in-law and mother in-law of the deceased, daughter of the informant and



no specific overt act has been attributed against the petitioners. In fact, due to some dispute in between deceased, Guria Devi and her husband, Sanjay Yadav, deceased committed suicide by putting fire but with ulterior motive the present case has been lodged with false allegation. Moreover, Sanjay Yadav, husband of the deceased, is already in custody.

Having regard to the facts and circumstances of the case, let the above named petitioners be released on bail, in the event of their arrest or surrender before the learned Court below within a period of six weeks from today, on furnishing bail bond of Rs. 10,000/- (ten thousand) each with two sureties of the like amount each to the satisfaction of the Additional Chief Judicial Magistrate-XII, Gopalganj, in connection with Bhorey P.S. Case No. 144 of 2016, subject to the condition as laid down under Section 438(2) of the Cr.P.C.
