The appeal is dismissed. No interference is warranted with the impugned order dated 11.03.2014 passed by the learned Single Judge keeping in mind that the appellant has already filed a suit with regard to the share or the right, title or interest over the



property for which compensation was awarded by National Highway authority. There is also compliance of the direction of the learned Single Judge by refunding the money now which he had taken as entire share, which is subject matter of adjudication before the civil court.
