8 01-08-2017 Learned counsel for the petitioners seeks permission to withdraw the present application with liberty to prefer an appeal before the State Appellate Authority against the order dated 6.8.2010 passed in Case No.44/2009 by the District Teachers Employment Appellate Authority, Araria.

Permission is accorded.

The petitioners shall file an appeal before the State Appellate Authority within a period of thirty days and the same shall be disposed of within the statutory period.

It has further been pointed out on behalf of the petitioners that the petitioners were granted interim protection vide order dated 19.09.2012 passed in C.W.J.C. No.14565 of 2010.

The petitioners will be at liberty to make a separate application before the State Appellate Authority during the pendency of the appeal within a period of ten days from the date of filing of the appeal and the same shall be disposed of within a period of twenty days from date of filing of such application.

With the aforesaid observation and direction, the present writ application stands disposed of.
