Heard Mr. Shailesh Kumar, learned counsel appearing for the petitioners and Mr. Prashant Pratap, learned Government Pleader No.2 for the State.

Although the petitioners herein pray for regularization but considering the stand taken in the 2nd supplementary counter affidavit, no indulgence can be granted. While it is the admission of the petitioners present at paragraph 7 of the writ petition that they have worked for 240 days prior to 11.12.1990 in so far as the



subsequent period is concerned, it is mentioned in paragraph 5 of the 2nd supplementary counter affidavit that they have been intermittently engaged but not working since long.

In the circumstances noticed no cause for indulgence is made out and the writ petition is accordingly disposed of.
