3 15-09-2017 Considering the fact that the contempt application complaining breach of the same order passed on 8.12.2011 in C.W.J.C. No.16435 of 2009 has already been disposed of and the contempt proceedings dropped vide order dated 9.5.2016 passed in M.J.C. No.2324/2015, a fresh contempt application is



not maintainable.

The petitioner can avail of the liberty granted for raising a fresh claim taking recourse to such remedy as may be permissible under law, but after the aforesaid order passed on 9.5.2016 in M.J.C. No.2324 of 2015 a fresh contempt application is not maintainable and is accordingly dismissed.
