ORAL ORDER

5 08-02-2017 The order, dated 24.01.2017, annexed as Annexure-D to the supplementary show-cause of O. P. Nos. 1 to 5, has been gone through. Provisional recognition has been



granted by the State authorities for a period of one year. The consideration of final recognition on a permanent basis is still being verified from records.

The contempt application is disposed off with a direction upon the Secretary, Higher Education, Government of Bihar, Patna that the decision with regard to the permanent affiliation must be taken at least a month before the expiry of one year period of temporary affiliation.
