4     14-12-2017             I.A. No. 8151 of 2016 is a petition for condonation of delay of 103 days. For the reasons indicated in the condonation application, delay is condoned. I.A. is allowed.

Heard learned counsel for the appellant. Perused the order dated 01.05.2015.

The sensitivity which the learned counsel for the appellant is showing on the observation of the learned single Judge especially in paragraph 14 is a passing reference and in no



manner lays down the law that may be an obiter but not the ratio of the judgment.

Appeal stands dismissed otherwise.

Before parting, the Court is informed that the private respondent has been exonerated by the High Court in the criminal appeal and a clean acquittal has been given. In view of the same, there is obligation upon the appellant to settle his post retirement dues without any further delay or harassment.
