Grievance of the petitioners, who are residents of the village in question, are with regard to grant of benefit of Indira Awas Yojna to persons who are not entitled to the privilege and who do not fall in the category of persons who are entitled for allotment of house under the scheme.



On petitioners’ own showing, it is seen that the petitioner have made a complaint before Respondent Nos.2, 3 and 4 and, that being so, we are not inclined to make indulgence into the matter. Instead, we direct Respondent Nos.2, 3 and 4 to look into the grievance of the petitioners and proceed to take action as permissible under law.

With the aforesaid, this application is disposed of.
