It is submitted jointly at the Bar that the case of the petitioner is covered by a decision rendered by two co-ordinate Benches of this Court dated 28.03.2011 passed in C.W.J.C. No.12887 of 2008 (Annexure 7) and order dated 26.02.2016 passed in C.W.J.C. No.4795 of 2014 (Annexure 8) respectively. Thus, it is contended that this case may be disposed of in terms thereof.

Accordingly, this writ application also stands allowed in terms of the aforesaid decisions and the order dated 21.12.1995
