Seeking exception to an order dated 12.08.2016 passed
by the learned Writ Court in C.W.J.C. No. 12946 of 2011 this appeal
has been filed under Clause 10 of the Letters Patent.

Based on certain judgments of the Full Bench and
finding that with effect from 31.07.2006 the post of Shiksha Mitra has



been abolished, now no relief can be granted to the appellant with regard to her termination from the post of Shiksha Mitra which was effected much before the cut off date, the writ petition has been dismissed.

In doing so, the learned Writ Court has not committed any error warranting reconsideration. The Letters Patent Appeal stands dismissed.
